Examinations, Major and Minor Fields of Study and Quality Point Average

The Academic Standards and Calendar Committee recommends that the Faculty Senate approve the following changes to the <u>University Manual</u>:

EXAMINATIONS

a. Add the following new paragraph 8.51,15:

8.51.15 Examinations given during the semester may be administered at a time other than the regularly scheduled class hours provided students are notified in advance in the <u>Schedule of Courses</u> and in the course syllabus. Examinations given at a time other than the regularly scheduled class hours may not be scheduled to begin earlier than 6:00 p.m. and may not occur on Saturday or Sunday. (See 8.39.10)

- b. Renumber existing paragraphs <u>8.51,15</u> and <u>8.51,16</u> as <u>8.51,16</u> and <u>8.51,17</u>.
- c. Add "(See 8.51.15)" as a reference notation to the end of paragraph 8.39.10.

<u>Rationale</u>: Concern has been expressed about the increasing number of departments that are scheduling common examinations during the semester in time periods that conflict with regularly scheduled classes and events. Students who are in Theatre 100, certain Music courses, rehearsals or practice sessions, or have scheduled work hours in the late afternoon find it necessary to cut a class. miss a rehearsal or practice, or not report to work in order to take an examination.

2. MAJOR AND MINOR FIELDS OF STUDY

Change paragraphs 8.20.50 and 8.20.61 as follows (changes are underlined):

8.20.50 Major Fields of Study. An undergraduate student's concentrated field of study in a degree-granting college shall be the student's "major"; University College students may have a "preferred major." The major field of study for graduate students shall be the student's "program." An "option" is a recognized path toward a major. Curricular requirements for majors and programs are defined in the University Bulletin. At least half of the credits required in an undergraduate student's major field of study must be earned at The University of Rhode Island. A student's major(s) or program(s) will be listed on the student's permanent academic record after graduation.

8.20.61 At least twelve of the eighteen credits required for a minor shall be at the 200-level or above. At least half of the credits required for a minor must be earned at The University of Rhode Island. A minimum average of 2.0 must be earned in the eighteen or more credits required for the minor.

<u>Rationale</u>: The Committee believes that, if a student's academic record is to list a major or a minor earned at The University of Rhode Island, there should be enough University credits to assure the quality of the major or minor.

OUALITY POINT AVERAGE

Change all references in the <u>University Manual</u> to "2.0" quality point average to "2.00."

<u>Rationale</u>: The quality point average that appears on all official student records is expressed in hundredth's. As the <u>University Manual</u> now reads, a student could ask that his/her quality point average be rounded to meet qualifications that are specified in several areas.
