

FACULTY SENATE

At its meeting of April 27, 1989, the Faculty Senate approved the following changes to sections 5.75.11 and 5.75.12 of the UNIVERSITY MANUAL recommended in the Report of the Administrator Evaluation Coordinating Committee for 1988-89:

- A. Amend section 5.75.11 to read as follows:

5.75.11 Each administrator evaluation committee shall consist of 3-5 members. Three members shall be chosen by the appropriate faculty group as defined in section 5.75.12, hereafter referred to as the constituent group. The administrator shall have the option to choose an additional member of the committee from the constituent group. In addition, for all administrators except the President, the immediate supervisor shall also have the option to choose an additional member of the committee from the constituent group. The Administrator Evaluation Coordinating Committee shall be responsible for facilitating the selection of the respective administrator evaluation committees.

- B. Amend section 5.75.12 "a)" by deleting "tenure-track. Section 5.75.12 "a)" to read as follows:

5.75.12 The constituent groups shall be defined as follows: a) all continuing members of the appropriate college faculties for academic deans with college faculties...

- C. Amend section 5.75.12 "c)" by adding "continuing." Section 5.75.12 "c)" to read as follows:

c) all continuing faculty who have taught at the College of Continuing Education during the three years immediately preceding the evaluation and chairpersons of academic departments for the Dean of the College of Continuing Education;
