FACULTY SENATE

At its meeting of May 11, 1989, the Faculty Senate approved the addition of the following second and third paragraphs to section <u>10.90.14</u> of the UNIVERSITY MANUAL recommended in the Report of the Administrator Evaluation Coordinating Committee for 1988-89:

Add the following second paragraph to section <u>10.90.14</u> of the UNIVERSITY MANUAL:

The Administrator Evaluation Committee (AEC) performing each evaluation other than that of the President shall meet with the administrator involved and his or her immediate supervisor to discuss the evaluation. The AEC performing the President's evaluation shall meet with the President to discuss the evaluation. All members of the constituent unit shall be notified in writing by the AEC as to when the meeting took place.

Add the following third paragraph to section <u>10.90.14</u> of the UNIVERSITY MANUAL:

The evaluation of an administrator by an AEC shall be made available to any subsequent AEC evaluating that same administrator and may be discussed in the meeting between the AEC, the administrator being evaluated and his or her supervisor.
