

FACULTY SENATE

On May 11, 1989, the Faculty Senate approved the addition of the following new section 4.47 of the By-Laws of the Faculty Senate recommended by the Executive Committee:

4.47 The Chairperson of the Administrator Evaluation Coordinating Committee shall be entitled to have his/her normal duties reduced by one-third, normal duties being specified in Article IV, paragraph 2, of the Constitution of the Faculty Senate, and entitlement shall follow automatically upon appointment. Funds for the reduced time of the chairperson shall be provided in the budget of the Faculty Senate.
