FACULTY SENATE

On December 7, 1989, the Faculty Senate approved the addition of the following second paragraph to section <u>10.90.14</u> of the UNIVERSITY MANUAL:

The Administrator Evaluation Committee (AEC) performing each evaluation other than that of the President shall meet with the administrator involved, and may meet with the immediate supervisor to discuss the evaluation. The AEC performing the President's evaluation shall meet with the President to discuss the evaluation. All members of the constituent unit shall be notified in writing by the AEC as to when the meeting took place.
