

FACULTY SENATE

On May 11, 1990, the Faculty Senate approved the following recommendation from the Annual Report of the Administrator Evaluation Coordinating Committee for 1989-90:

Amend section 10.90.11 of the UNIVERSITY MANUAL to read as follows:

10.90.11 The President, the Provost, the Vice Provost for Research and Service, and all academic deans including the Deans of the Graduate School, University College, College of Continuing Education and of the Library are subject to faculty evaluation. An administrator must be in the position at least two years before an evaluation is conducted. After the first evaluation, the administrator will be subject to faculty evaluation once every five years.
