CURRICULAR REPORT FROM THE GRADUATE COUNCIL TO THE FACULTY SENATE  
REPORT NO. 1991-92-2

At its Meeting No. 292 held on October 4, 1991, the Graduate Council considered and approved the following curricular matters which are now submitted to the Faculty Senate for confirmation as indicated.

I. Courses Requiring Confirmation by the Faculty Senate.

A. College of Arts and Sciences

1. Department of Political Science

a. Add (New)

PSC 553 Scope and Methods of Political Science I,3  
Study of political science as a discipline, its development in relation to other social sciences and survey of political theories, concepts and analytic models. Pre: Graduate Standing. (Sem) Leduc

- 3) THE 313 Acting Workshop (I, 1) A voice-movement workshop to be taken concurrently with 311. (Studio 2) Pre: Open only to students enrolled in 311. Guest Artist
- 4) THE 314 Acting Workshop (II, 1) A voice-movement workshop to be taken concurrently with 312. (Studio 2) Pre: Open only to students enrolled in 312. Guest Artist

b. CHANGE: Credits, method of instruction and prerequisite for the following courses:

- 1) THE 211, 212 Basic Acting I (I and II, 2)... (Studio 4) 211: "Pre: 111, 117 or permission of instructor; 213 must be taken concurrently." 212: "Pre: 211 and permission of instructor; 214 must be taken concurrently."
- 2) THE 311, 312 Intermediate Acting I, II (I and II, 3)... (Studio 6) 311: "Pre: 211, 212 and permission of instructor; 313 must be taken concurrently." 312: "Pre: 311 and permission of instructor; 314 must be taken concurrently."

c. CHANGE: Acting Specialization in the BFA program to read as follows:

ACTING. Students selecting acting must complete an additional 31 credits distributed as follows: THE 117 (3), 211 and 212 (4), 213 and 214 (2), 300 or 301 (3), 311 and 312 (6), 313 and 314 (2), 400 or 401 (3), 411 and 412 (6), 417 and 418 (2).

B. College of Business Administration

Department of Marketing

DISCONTINUE: Marketing-Textiles Option within the Marketing Major.

C. College of Engineering

1. Department of Civil and Environmental Engineering

CHANGE: B.S. curriculum as follows:

- 1) Delete the 3-credit "approved math elective" in the first semester of the senior year.
