At its Meeting No. 301 held on December 11, 1992, the Graduate Council considered and approved the following curricular matters which are now submitted to the Faculty Senate for information or confirmation as indicated.

#### I. Matters of Information.

- . College of Resource Development
  - 1. Department of Food Science and Nutrition
    - a. Temporary Course

FSN 522X Community Nutrition II,1 Principles of community nutrition. Student assessment of a community, identification of nutritional problems, design and implementation of an intervention program, and evaluation of the results. (Lec 3 for five weeks) Pre: FSN 444 or permission of instructor. Greene

#### II. Matters Requiring Confirmation by the Faculty Senate.

- A. College of Resource Development
  - 1. Department of Food Science and Nutrition
    - a. Change M.S. program requirements to read:

# Master of Science

Program requirements: thesis; 2 credits of FSN 511; a minimum of 3 credits in biochemistry, chemistry, microbiology or physiology, in Food Science--FSN 422, 431, 432 and 502 OR in Nutritional Science--a minimum of 6 credits (FSN 441 plus one 500-level course). If the student has taken any of the courses as an undergraduate, alternate courses should be taken in the same area. All resident students are expected to be continuously registered in FSN 511 or 512 for no program credit, but no more than 2 credits of FSN 511 can be used for program credit.

- B. College of Human Science and Services
  - 1. <u>Department of Textiles, Fashion Merchandising and</u> Design

TMD 503 Advanced Textiles -title/sem/desc/pre

TMD 503 Topics in Textile Science I or II or SS,3 Advanced study in a particular area of textile science. One topic will be studied from a list which includes dyeing, finishing, printing, polymer and fiber chemistry, dyestuff chemistry, and color science. May be repeated up to three times with different topics. (Lec 2 Lab 2) Pre: Graduate standing, 303 or equivalent, or permission of instructor. Bide

TMD 510 Historical Research Methods: Textiles and Furnishings -title/sem/desc/pre

TMD 510 Research Methods in Textiles I or II,3 Application of research methodology to the study of textiles and clothing. Approach is multidisciplinary in that experimental, social science, and historic methods are covered. (Lec 3) Pre: Graduate standing or permission of instructor. Staff

#### c. Add (New)

TMD 570 Topics in Historic Textiles/Costume I or II or SS,3 Advanced study in a particular area of historic textiles or costume using artifactual and documentary primary sources. Use of historic textile and costume collection. May be repeated for a maximum of six credits. (Lec 3) Pre: TMD 340, 440 or equivalent. Ordonez or Welters

REPORT OF THE NEW PROGRAM REVIEW COMMITTEE

December 1992

#### BACKGROUND:

The New Program Review Committee held four meetings during November and December 1992 and reviewed the proposed new doctoral programs in Education, Industrial and Manufacturing Engineering and Marine Affairs which had been forwarded by the Graduate Council. The following criteria as stated in section <u>8.85.22</u> of the UNIVERSITY MANUAL were considered in the review:

- ,-- Centrality of the program to the mission of the University of Rhode Island;
- -- Extent to which the program would contribute to the University's fulfillment of its three main responsibilities, teaching, research and service;
- -- Relationship of the program to the developmental plans of the University;
- -- Projected cost effectiveness considerations.

On December 10, 1992, the New Program Review Committee voted as follows:

1) That the Ph.D. in Industrial and Manufacturing Engineering be forwarded to the faculty Senate without ranking or assignment of Class A, B, or C under the provisions of section 8.85.24 of the UNIVERSITY MANUAL:

> ...If programs do not require the allocation of general revenue funds for direct costs, or if the program can be entirely supported by reprogramming existing departmental funds, or if the amount of general revenue funds required per year does not exceed the current calendar year minimum salary of an instructor, no review under 8.85.20 shall be required...

2) That the Ph.D. in Marine Affairs be assigned a <u>Class B</u> recommendation (proposed new program to compete for resources on an equal basis with all other University activities);  That the Ph.D. in Education be assigned a <u>Class C</u> recommendation (proposed new program to be implemented if additional funds are made available to the University).

## **RECOMMENDATIONS:**

The New Program Review Committee recommends the following:

- That the Faculty Senate approve the proposed Ph.D. in Industrial and Manufacturing Engineering (attached pp. 21-46) without assignment of Class A, B, or C under the provisions of section <u>8.85.24</u> of the UNIVERSITY MANUAL;
- That the Faculty Senate approve the proposed Ph.D. in Marine Affairs (attached pp. 47/64) with a Class B designation;
- That the Faculty Senate approve the proposed Ph.D. in Education (attached pp. 65-91) with a Class C designation.
