CURRICULAR REPORT FROM THE GRADUATE COUNCIL TO THE FACULTY SENATE REPORT NO. 1992-93-5

At its Meeting No. 302 held on February 5, 1993, the Graduate Council considered and approved the following curricular matters which are now submitted to the Faculty Senate for information or confirmation as indicated.

- I. Matters of Information.
 - A. Graduate School of Oceanography
 1. Temporary Course

OCG 688X Seminar in Deep-Sea Biology II,2 Seminar course involving reading and discussion of seminal papers in deep-sea biology and reviews of topics chosen by class participants. Pre: OCG 561. Wishner

- II. Matters Requiring Confirmation by the Faculty Senate.
 - A. College of Human Science and Services
 - 1. Department of Textiles, Fashion Merchandising and Design
 - (a) Add (New)

TMD 532 Consumer Behavior in Fashion Retailing I or II,3 Fashion retailing management's use of explanatory and predictive models of consumer behavior relating to fashion merchandising in establishing retail policy and strategy. (Lec 3) Pre: Graduate standing or permission of instructor. Harps-Logan

TMD 542 Fashion Promotion I or II,3
Emphasis on understanding and applying the principles of fashion
retailing communication. Evaluation and application of effective
promotional activities such as visual merchandising and fashion
shows to trade and retail levels of fashion merchandising. (Lec 3)
Pre: Graduate standing or permission of instructor. Harps-Logan

TMD 552 Retail Price Strategy I or II,3 Economic, financial, legal and fashion retailing principles are examined and integrated into a functional model in order to analyze management's pricing decisions and strategies for fashion merchandise. (Lec 3) Pre: Graduate standing or permission of instructor. Harps-Logan

(b) Change in program requirements for the M.S. in Textiles, Fashion Merchandising and Design to reflect the changes in course offerings to read:

<u>Program requirements</u>: Thesis option - completion of a minimum of 30 credits, including 6 credits of thesis research. Non-thesis option, completion of a minimum of 33 credits, including at least one course that requires a substantial paper involving significant independent study, and written comprehensive exams. TMD 510 is a requirement for all students.

For the textile science specialization: TMD 503 and 510; half of the remaining elective credits must be from textiles, fashion

merchandising and design courses numbered 500 and above.

For the historic textiles and costume specialization: TMD 510, 520, 524, and a supervised internship (TMD 530, 2-4 credits); half of the remaining elective credits must be from textiles, fashion merchandising and design courses numbered 500 and above. A minimum of 9 credits is required to achieve a competency level in an allied field such as art history, history, or anthropology; this may result in a program of more than thirty credits. The committee may elect to waive this requirement if the candidate has adequate preparation in the allied field as an undergraduate. Candidates lacking undergraduate courses in textile science and historic costume may be required to make up deficiencies without graduate credit.

For the fashion merchandising specialization: TMD 510 and 524; 6 credits to be selected from TMD 532, TMD 542, and TMD 552; half of the remaining elective credits must be from textiles, fashion merchandising and design courses numbered 500 and above. Candidates lacking undergraduate courses in textile science and fashion merchandising may be required to make up deficiencies without graduate credit.

(c) Change in requirements for the non-thesis option--deleting TMD 550 and 560 as requirements.

The revised non-thesis option would require the completion of 33 credits, half of which must be TMD courses numbered 500 or above (including TMD 510), a major paper, comprehensive examinations.

UNIVERSITY CALENDAR FOR 1994-95 REVISED

On January 28, 1993 the Faculty Senate referred Academic Standards and Calendar Committee Report #1992-93-1: University Calendar for 1994-95 back to the Academic Standards and Calendar Committee for reconsideration.

The Academic Standards and Calendar Committee met on Monday, February 8, 1993 to reconsider the proposed calendar based upon the advice of the Faculty Senate. The Committee is now presenting a revised 1994-95 University Calendar for consideration by the Faculty Senate.

In addition to the proposed calendar for 1994-94, the committee has attached a possible 14-week fall semester calendar for information.

With regard to the 1994-95 Calendar, the Academic Standards and Calendar Committee recommends approval of the following motions:

 That for the 1994-95 academic year the Faculty Senate grant an exception to section 8.70.22 of the UNIVERSITY MANUAL to permit the scheduling of one week-day reading day after the last day of classes.

Section 8.70.22 of the UNIVERSITY MANUAL reads as follows:

8.70.22 A minimum of two week-day reading days will be scheduled after the last day of classes.
