FACULTY SENATE

On May 13, 1993, the Faculty Senate approved a motion to rescind its approval of the recommendations on the transfer of University College and Special Academic Programs contained in the Two Hundred and Ninety-Ninth Report of the Curricular Affairs Committee, (Senate Bill #92-93--30), and approved the following revised recommendations as amended:

1. That University College and Special Academic Programs be returned to Academic Affairs as a full administrative unit. This would comprise University College (including New Student Programs and the Academic Advising Program for Athletes), the Office of Internships and Field Experience (UYA), the Learning Assistance Center, the National Student Exchange Program and Study Abroad. The transfer would not include the Counseling Center, Career Services, or the Special Programs for Talent Development.
2. In view of reports of disproportionate cuts suffered by University College and Special Academic Programs, a careful analysis of its Budget must be conducted by the Vice President for Business and Finance prior to the transfer to ensure that the University College and Special Academic Programs is returned to Academic Affairs with its fair share of funding.
3. That the Curricular Affairs Committee and the University College and General Education Committee review the placement of the Special Programs for Talent Development and report to the Faculty Senate no later than December 9, 1993.
