As you know, I had requested an extension of the period for my approval of Senate Bill #92-93--39 (Research Policy and Facilities Committee and Graduate Council Joint Report on Sponsored Research). My request for an extension was based on my desire to consider carefully a concern expressed by Mr. Angelo Mendillo on behalf of several University employees.

The expressed concern was related specifically to the newly proposed section of the <u>University Manual</u>, Section 10.49.11. As approved by the Faculty Senate, it was believed that this new section would create a potential personal liability exposure for some University employees whose job it is to process paperwork for sponsored research. Upon review, Legal Counsel concurred with this oncern.

At my request, Vice Provost Lord convered a group composed of Robert Coleman, Robert Gutchen, Ronald Hedlund, James Leslie and Kent Morrison to reconsider this issue. After reexamining the intent of the legislation and the la guage promulgated to implement that intent, they have suggested revised language. They believe this revision is consistent with the original intent of the proposed new section and addresses the previously expressed concern (a copy of their revision is attached).

At this time, I have "Disapproved" Senate Bill 92-93--39 and am returning it to you. Should the Faculty Senate accept the revised language, I am prepared to approve it, and I look forward to an opportunity in the near future to be able to do so.

Thank you for your patience and assistance.

REPORT OF THE EXECUTIVE COMMITTEE IN RESPONSE TO PRESIDENT B REQUEST FOR FACULTY SENATE CONSIDERATION OF HIS STRATEGIC PLAN September 14, 1993

The Executive Committee recommends the following with regard to the President's Strategic Plan (September 8, 1993) and the Report of the Joint Academic Steering Committee (March 1, 1993).

In order to provide the Faculty Senate and the University Community the opportunity to give full consideration to, and if appropriate, to act upon, the President's Strategic Plan, the Executive Committee recommends:

- That the Faculty Senate agree to direct its attention and focus its activities on responding to the President's Strategic Plan as proposed on September 8, 1993;
- That the Faculty Senate postpone definitely further consideration of "the Mission Statement for the University of Rhode Island," which is currently on the floor of the Faculty Senate, until the November 18, 1993 Meeting of the Faculty Senate;
- 3. That the Faculty Senate direct that the Ad Hoc Oversight Committee (AHOC) inform the "appropriate committees" to which JASC recommendations had been transmitted, that consideration of the JASC recommendations are being suspended by the Senate until November 18, 1993, or until such time as the Faculty Senate may determine;
- That the Faculty Senate direct the AHOC to suspend further activity until November 18, 1993, or until such time as the Faculty Senate may determine;
- 5. That the Faculty Senate suspend the charge and operation of the UCGE Subcommittee on Liberal Education, until such time as the Faculty Senate may determine.
