Curricular Matters Which Require Approval by the Faculty Senate.

A. College of Arts and Sciences

1. Department of Communication Studies

*CHANGE: Number of credits for COM 471, 472 to "1-3" and method of grading to "S/U only."

2. Film Studies Committee

ADD: Minor in Film Studies as follows:

Students who declare a film studies minor must complete 18 credits of courses in which film or video are the primary tests of study including a minimum of 3 credits in each of the 3 following approaches to film study: Aesthetic (ARH 374, ART 215, ART 316); Cultural (AAF 300H, HIS 358, ITL 315); Literary (ENG 300, ENG 346). Experimental, special topics or other irregular courses in film may be used to fulfill requirements for this minor with permission.

Fundamentals of Plant Biology emphasizing the
