Section 8.53.30 of the UNIVERSITY MANUAL

The Academic Standards and Calendar Committee recommends that the Faculty Senate approve the following addition to section <u>8.53.30</u> of the UNIVERSITY MANUAL:

Courses numbered below 100 that are graded on an S/U basis shall not be included in the calculation of a student's quality point average or credits earned.

Section 8.53.30 would read as follows (change is in boldface):

8.53.30 S/U Courses. Certain courses do not lend themselves to precise grading (e.g., research, seminar). For these courses, only a Satisfactory (S) or Unsatisfactory (U) shall be given to all students enrolled. To qualify as an S/U course, the course must be approved by the Faculty Senate after recommendation by the Curricular Affairs Committee and/or the Graduate Council. S/U courses shall be so labeled in University catalogs and bulletins. An S/U course is not to be counted as a course taken under the Pass/Fail grading option. Courses numbered below 100 that are graded on an S/U basis shall not be included in the calculation of a student's quality point average or credits earned.

Rationale: At its meeting of November 5, 1993, the Academic Standards and Calendar Committee discussed the grading policy for courses numbered below 100. After considerable discussion, the committee agreed that the practice of having what are essentially non-credit classes adversely affect a student's QPA was not appropriate and decided to recommend the appropriate change in section 8.53.30.
