Faculty Senate Curricular Affairs Committee Three Hundred and Eighteenth Report

At the April 11, 1994 meeting of the Curricular Affairs Committee the following matters were considered and are now presented to the Faculty Senate.

Curricular Matters Which Require Confirmation by the Faculty Senate

- A. College of Pharmacy
 - CHANGE: Transfer requirements for pre-pharmacy students from University College to the College of Pharmacy to read as follows:

Among the pre-pharmacy students requesting transfer from University College to the College of Pharmacy at the end of three semesters, priority will be given to those applicants having a 2.5 average or better in required pre-professional courses (CHM 101, 102, 112, 114, 227; ZOO 111, 121, 242, and 244; MTH 131 and MIC 201) with no grade less than C- in any of these courses, and an overall QPA of 2.00. Applicants with an average between 2.0 and 2.5 in these courses will be considered for admission on a competitive basis along with other University of Rhode Island undergraduate students and transfer students from other institutions. Applicants with a QPA of less than 2.00 for the designated pre-pharmacy courses will not be considered for admission to the College of Pharmacy. At the end of four semesters, the foregoing courses plus CHM 226, 228; STA 307 and BCH 311 (or equivalent courses where permitted) will be included in the calculation of the pre-professional quality point average.

B. College of Resource Development

Departments of Plant Sciences and Natural Resource Science

CHANGE: Code for NRS 322 Power Units to "PLS."

C. Community Service

1. ADD: The following courses:

C.A.C. #318--94-4-12

- a. CSV 301 Course-Based Community Service (I or II, 1-3) Learning through a community service experience related to course content. Experience defined by a job description and learning contract, includes orientation and reflection. (Practicum) Pre: junior standing or above or permission of course instructor. Concurrent enrollment in a course offering community service experience required. May be repeated for a maximum of 6 credits. S/U only. Staff
- b. CSV 302 Community Service at URI (I or II, 2-4) Learning through a community service project addressing a specific community need at the University of Rhode Island proposed and supervised by an instructor. Includes mandatory seminar. Projects vary each semester. (Practicum) Pre: junior standing or above or permission of course instructor. May be repeated for a maximum of 8 credits. S/U only. Staff
- c. CSV 303 Service in the Community (I or II, 2-4) Learning through a community service project addressing a specific off-campus community need proposed and supervised by an instructor. Includes mandatory seminar. Projects vary by instructor. (Practicum) Pre: Junior standing or above or permission of course instructor. May be repeated for a maximum of 8 credits. S/U only. Staff

The total number of credits in community service which may be earned toward graduation may not exceed 12.

After approval by the relevant department chair and dean, community service projects for credit will be reviewed by the Curricular Affairs Committee Subcommittee on Community Service as follows:

*2. ADD: The following new sections to the By-Laws of the Faculty Senate:

4.88 Curricular Affairs Committee Subcommittee on <u>Community Service</u>. This subcommittee shall maintain liaison with the Curricular Affairs Committee and the dean of University College and Special Academic Programs for mutual information and joint action regarding the place of community service in the university's curricula. This subcommittee shall review and act upon proposals for existing Community Service courses and, when appropriate, propose revisions to the procedures for course approval and the standards for such courses, and recommend changes in Community Service course offerings.

* Because By-Laws changes may not be voted upon at the meeting at which they are first moved, this portion of the report was not voted upon by the Faculty Senate on April 28, 1994.

C.A.C. #318--94-4-12

<u>4.89</u> The Subcommittee on Community Service shall consist of one member of the Curricular Affairs Committee, the Dean of University College and Special Academic Programs or designee, and three members of the university faculty with a special interest in Community Service in the curriculum. The Chairperson shall be elected by its members.

Emphasis on quantitative measurements and data analyses used in wildlife population research. (Lec. 2, Lab. 3) Pre: ZOO 262 and STA 308 or 409 or permission of instructor. Husband
 - b) NRS 406 Wetland Wildlife (I, 3) Introduction to management of wetland wildlife. Emphasis on management techniques used for major wetland types, waterfowl, furbearers, and nongame wildlife. (Lec. 2, Lab. 2) Pre: ZOO 262 or permission of instructor. Eddleman

CHANGE: description, prerequisite and method of instruction for NRS 410:

NRS 410 Fundamentals of GIS (I, 3) Emphasis on using a geographic information system (GIS) to create a geographically referenced spatial database, spatial topology, data visualization, computer-assisted map making, and spatial data query and analysis. (Lab. 6) Pre: Past or simultaneous enrollment in 409 or 509. August

 - * b) NRS 409 Concepts in GIS (I, 3) Discussion of the unique properties of spatial data, GIS data structures, accessing existing spatial data, and applications of GIS in the environmental sciences. (Lec. 3) Pre: ZOO 262 or permission of instructor. Not for graduate credit. August

At the March 28, 1994 meeting of the Curricular Affairs Committee, the following matter was considered and inadvertently omitted from the 317th Report of the Curricular Affairs Committee. It is now presented to the Faculty Senate for confirmation:

College of Arts and Sciences

Department of Political Science

CHANGE: The B.A. program requirements in Political Science to read:

Students selecting this field must complete a minimum of 30 credits (maximum 45 credits) in political science, including PSC 113 and 116.

The remaining 24 credits will reflect the student's emphasis, though at least one course must be selected in each of the following three subfields: American Politics, World Politics, and Political Theory.
