CURRICULAR REPORT FROM THE GRADUATE COUNCIL TO THE FACULTY SENATE Report No. 1996-97-6-A

At Meeting No. 337 held February 21, 1997 the Graduate Council considered and approved the following curricular matters which are now submitted to the Faculty Senate for confirmation as indicated.

- I. Matters Requiring Confirmation by the Faculty Senate.
 - A. College of Human Science and Services
 - 1. Department of Communicative Disorders
 - a. Change in admission requirements for programs in Audiology and Speech-Language Pathology to add "GRE or MAT...".
 - B. Colleges of Resource Development and Arts and Sciences
 - 1. Departments of Environmental and Natural Resource Economics and Economics
 - a. Change in Primary Listing

ECN 527, 528, 576 should be changed to-

REN 527(or ECN 527); REN 528 (or ECN 528); REN 576 (or ECN 576).

These courses will still be crosslisted, but REN becomes the primary listing with the full course description in the REN course section. In the ECN course section, list only the course numbers 527, 528, 576 with titles and with a notation under each course title to indicate "See Resource Economics 527; See Resource Economics 528; See Resource Economics 576".
