

CONDITIONAL REINSTATEMENT

Last year, the Academic Standards and Calendar Committee considered a request from the Registrar's Advisory Committee that the provisions of the UNIVERSITY MANUAL on conditional reinstatement be modified to permit, in exceptional circumstances, a second conditional reinstatement.

Following is the existing section 8.25.16 of the UNIVERSITY MANUAL:

8.25.16 Students shall be allowed only one conditional reinstatement.

The Academic Standards and Calendar Committee recommends that section 8.25.16 of the UNIVERSITY MANUAL be amended to read as follows:

8.25.16 Students shall normally be allowed only one conditional reinstatement. However, after a significant time of separation from the University (no less than five years), students who demonstrate a seriousness of purpose and evidence of academic achievement may, upon recommendation of the dean of the college to which they are applying, be granted a second conditional reinstatement. Students may also have a second conditional reinstatement if, while on dismissed status, a student earns an academic degree from a regionally accredited institution.
