October 12, 1999

At the October 7, 1999 meeting of the University College and General Education Committee, the following matters concerning the current General Education Program were considered and are now presented to the Faculty Senate.

SECTION I

Informational Matter

On October 7, 1999, the UCGE Committee approved the recommendation from the College of Arts and Sciences that the topic "Southeast Asian Culture and History" be included as an approved topic under LET 151 in the <u>Letters (L) area.</u>

SECTION II

Matters Requiring Confirmation

A. The UCGE Committee recommends that the Faculty Senate approve the assignment of the following courses into the appropriate general education area as designated below:
