Additions to the Existing General Education Program

The UCGE Committee recommends approval of the assignment of the following three Film Studies Courses into the *Fine Arts and Literature (A)* area of the existing General Education Program for a limited period of time. These courses are subject to the provisions of the approved general education proposal that each course in each area be reviewed and, if the faculty member wishes, re-proposed in accordance with the new guidelines:

- a. FLM 101 Introduction to Film and Screen Studies
- b. FLM 201, History of Film
- c. FLM 203, Film Theory
