CURRICULAR REPORT FROM THE GRADUATE COUNCIL TO THE FACULTY SENATE: REPORT NO. 2000-2001-8

(As approved by the Faculty Senate on April 12, 2001)

At meeting No. 370 held March 23, 2001, the Graduate Council considered and approved the following curricular matters which are now submitted to the Faculty Senate for information or confirmation as indicated.

I. Matters Requiring Confirmation by Faculty Senate

Change the list of specializations in the Food Science option to read (changes underlined): Marine food product and process development; food structure and rheology; fish mince and surimu technology; seafood flavor; food safety and quality assessment.
