## **Faculty Senate**

On April 26, 2001, the Faculty Senate approved the following recommendation of the University College and General Education Committee:

Add BIO 101 and BIO 102 "Principles of Biology I and II" to the <u>Natural Sciences (N)</u> area of the existing General Education Program for a limited period of time. These courses are replacing BIO 112, 113 and are subject to the provisions of the approved general education proposal that each course in each area be reviewed and, if the faculty members wish, reproposed in accordance with the new guidelines.
