

The University College and General Education Committee considered the following matters at their meeting of April 3, 2008. They are now presented to the Faculty Senate for confirmation.

I. English Communications - Writing (ECw) Core Area

The UCGE Committee recommends that the Faculty Senate approve the following course for the (ECw) area of the General Education program:

WRT 303 Public Writing (three of the following skills: speaking effectively, reading complex texts, writing effectively, using information technology)

II. Letters (L) Core Area

The UCGE Committee recommends that the Faculty Senate approve the following course for the (L) area of the General Education program:

HPR 201 Honors Colloquium for fall 2008 - "Global Change"
(*reading complex texts, speaking effectively, writing effectively, using quantitative data, using qualitative data, using information technology*)

III. Natural Sciences (N) Core Area
