### Faculty Senate Curricular Affairs Committee Five Hundred and Twenty-Sixth Report

At the September 21, 2015 meeting of the Curricular Affairs Committee and by electronic communication, the following curricular matters were considered and are now presented to the Faculty Senate.

### **CURRICULAR CHANGES**

### A. College of Arts and Sciences:

1) Creation of a Double Counting Motion of up to 12 credits: (see Appendix A) Undergraduate students in the College of Arts and Sciences shall be allowed to use up to 12 credits of approved courses interchangeably for two or more separate majors among those programs in the College of Arts and Sciences which accept or require said courses.

### 2) Changing Course Code from ARH to ART: (see Appendix B)

The Department of Art & Art History is submitting a package of course change proposals with the purpose of changing the coding of Art History courses from ARH to ART.

Historically all courses in our department were coded ART. The change to ARH was made when we were the Department of Art to distinguish Art History as a separate discipline. More recently the name of the department was changed to Art & Art History so we no longer feel the separate course code is necessary. It would also conform to current usage at RIC and CCRI and schools with similar sized programs such as UNH and Eastern CT State University.

Change course code for all ARH courses.

Notice of Change for Faculty Senate

At its March 2, 2015 meeting, the College of Arts and Sciences Curriculum Committee approved the following motion. The College faculty discussed the motion at their meeting on March 31,

2015. The college faculty voted to approve the motion and send it on to the Curricular Affairs Committee.

### **Double Counting Motion**

"Undergraduate students in the College of Arts and Sciences shall be allowed to use up to 12 credits of approved courses interchangeably for two or more separate majors among those programs in the College of Arts and Sciences which accept or require said courses."

This motion was spurred by a request from the Department of Communication Studies to permit undergraduate students majoring in two programs of the Harrington School of Communication and Media to double count up to 12 credits in Harrington School courses for both of those majors. In the request the example was given of students who would like to combine majors in Communication Studies and Public Relations but who find it difficult to do so under the current regulations. The Chair of Communication Studies pointed out that when students do complete both majors, they take seats in Communication Studies courses which could be freed up for other students, should some double counting be permitted.

Assistant Dean Smith explained to the Curriculum Committee that the current practice of the Dean's Office is to allow Arts and Sciences undergraduates to double count two courses toward each of two majors if both majors are offered by the College of Arts and Sciences and to double count one course if one of the majors is offered by another college. Dean Smith reported that this practice predated his affiliation with the College of Arts and Sciences. As far as the Curriculum Committee has been able to determine, the practice is not based on legislation approved by the College of Arts and Sciences faculty, it has not been published in the University Catalog or on the College website, nor is it mentioned in the recently compiled College By-Laws.

The purpose of the motion presented by the Curriculum Committee is to establish an official College policy which will be published, once it has been approved, The Curriculum Committee was influenced in making its recommendation by the following considerations:

1. More than a quarter of the students who completed undergraduate majors in the College of Arts and Sciences last year completed two majors. Some completed three majors. Students value the recognition which they receive for completing two or more majors.

2. The potential for counting courses for more than one major exists primarily due to the creation or interdisciplinary majors and to the cross-listing or courses. The Curriculum Committee assumes that these phenomena will become even more common in the future, given their encouragement in the Academic Plan. Thus it is timely to adopt and publish a rule which governs the possibility of double counting.

3. The policy proposed by the Curriculum Committee allows for some double counting but puts a cap on it. This represents a middle ground between barring all double counting and allowing unlimited double counting which could lead potentially to buy-one-get-one-free combinations of double majors.

4. College-wide policy which permits double-counting would be fairer to students in the College than one limited to Harrington School majors.

#### Curriculum Requirements

In order to earn a degree in the College of Arts and Sciences, the student must meet requirements in three main areas: the major, Basic Liberal Studies, and electives. A description of these areas follows.

 The Major. Every student is required to specialize in a particular area or discipline called the major. The requirements for each major vary from field to field, and are described in this section. Any student who has met the requirements for two separate majors within the Bachelor of Arts, Bachelor of Science, Bachelor of Fine Arts, or Bachelor of Music degree programs in the College of Arts and Sciences has earned a double major and may have both fields listed on the transcript.

In order to meet graduation requirements, a student must maintain a 2.00 grade point average in all courses required for his or her major. This restriction applies in every case, unless a different policy is explicitly stated in the description of the degree program. At least half of the total number of credits needed in a given major must be earned at the University of Rhode Island.

Curricular Modifications. In consultation with the advisor, and with the approval of the department chairperson, a student will be permitted to modify the normal requirements of the major. The decision of the department chair is final. Requirements outside the major may be modified only with approval of the Scholastic Standing and Petitions Committee of the College of Arts and Sciences. Petition forms are available in the Office of the Dean. Minimum grade point average and total credit requirements are not petitionable.

2. Basic Liberal Studies. In the College of Arts and

Sciences, general education requirements are called Basic Liberal Studies and are required of all students. This series of courses is Intended to ensure that students have educational experiences that will help them to become informed and responsible participants in society and contribute to the full development of their individual capabilities. The Basic Liberal Studies program embodies the philosophy and fundamental knowledge that characterizes an arts and sciences education. 9

The Department of Art & Art History is submitting a package of course change proposals with the purpose of changing the coding of Art History courses from ARH to ART.

This proposal continues a strategy started last year when we consolidated the Studio Art curriculum, deleting all 400 level courses except for our capstone course Art 405. At the time Professor Ron Onorato and I met with Bob Bullock and Patricia Morokoff who were supportive of these plans. We then received detailed instructions from Nancy Neff on how to proceed with the changes.

Included in this package is a spreadsheet listing all current ART and ARH courses and a list of the proposed changes. Course change proposal forms are being submitted for Art History courses that had a pre-requisite of another Art History course. We are including the Major descriptions and worksheets for the BA and BFA in Art and the BA in Art History with the changes noted. Highlights in yellow or blue note changes from ARH to ART. Highlights in red are to be eliminated. In addition to changing ARH to ART, references to ART 300 Art Gallery Internship are being eliminated. That course was deleted last year. We are also attaching the catalog pages with the changes highlighted.

Historically all courses in our department were coded ART. The change to ARH was made when we were the Department of Art to distinguish Art History as a separate discipline. More recently the name of the department was changed to Art & Art History so we no longer feel the separate course code is necessary. It would also conform to current usage at RIC and CCRI and schools with similar sized programs such as UNH and Eastern CT State University.

There are no overlaps in numbers between Art and Art History courses. We would like to see the header in the course of instruction section of the catalog read "Art & Art History (ART)". We have a list of departments that have Art History courses listed in their curriculum and will be contacting them after this application is made to your committee.

In this package there is one more course deletion form for ART 306. This was missed last year when we were consolidating studio courses.

### Arts and Sciences Undergraduate Programs

#### Africana Studies

Faculty: Professor Quainoo, interim director. Professors Dilworth, OkekeEzigbo, and Weisbord; Associate Professors Harris, and Schwartz; Assistant Professor Ferguson; Adjunct Faculty Barber, McCray, and Smith.

The Africana program is an interdisciplinary program offered jointly by URI and Rhode Island College. Students in this program may take courses at either institution to fulfill major requirements. Students may also choose to study abroad in affiliated programs in the following countries: Belize, Cape Verde, and Ghana. Programs related to the African diaspora may also qualify for AAF credit. The major's objective is to broaden students' intellectual and global experiences through the study of Africa and African diaspora.

Students selecting this major must complete a minimum of 30 credits including AAF 201 and 202. Six credits must be selected from each of the following areas: history and politics (AAF 290, 300; AAF/HIS 150, 359, 388; AAF/PSC 380, 408, 410, 415, 466; PSC 372; WMS 351); arts and humanities (AAF/ARH 330, 331; AAF/ENG 247, 248, 360, 362, 363, 364, 474); and social and behavioral science (AAF 300; AAF/ACOM 333; COM 310A, 465). The remaining 6 credits must be chosen from courses approved for the above groups.

A total of 120 credits is required for graduation. At least 42 of these must be in courses numbered 300 or above. A minor is also available (see Africana Studies) in Interdepartmental Minors.

#### Anthropology

The Department of Sociology and Anthropology offers the degree of Bachelor of Arts (BA.) in anthropology.

Faculty: Professor Peters, chairperson. Professor Poggie; Assistant Professors Bovy, Dunsworth, and GarciaQuijano; Professors Emeriti LaVelle and Loy.

Students desiring to major in anthropology must complete a total of 30 credits (maximum 45 credits) in anthropology including introductory courses: APG 200, 201, 202, and 203 (12 credits); methods courses: APG 300, 302, 412, or 417 (3 credits); theory courses: APG 401 (3) and APG 327 or 417 (3), for a total of six credits. Note: APG 417 may be taken to fulfill either the methods or theory requirement, but not both. The remaining nine credits may be from any APG course. No more than six credits in independent study and/or field experience courses may be used toward the 30 credits required for the major.

It is strongly recommended that anthropology majors take at least one course in inferential statistics (e.g., STA 308 or 409y, complete a foreign language through the intermediate level, and gain computer proficiency. Early in the junior year, students who plan to go on to graduate school should meet with their advisor for curricular counseling.

A total of 120 credits is required for graduation. At least 42 of these must be in courses numbered 300 or above. In order to transfer into the anthropology program from University College, a student must have completed at least 24 credits and have earned a minimum of a 2.00 GPA.

#### Art and Art History

The Department of Art offers a Bachelor of Arts (B.A.) degree with a major in either art or art history, and a Bachelor of Fine Arts (B.F.A.) degree in art.

Faculty: Professor Onorato, chairperson. Professors Dilworth, Hollinshead, Matthew, Pagh, Richman, and Wills; Associate Professors Anderson and Hutt; Professors Emeriti Calabro, Fraenkel, Holmes, Klenk, Leete, and Roworth.

#### BACHELOR OF ARTS

Art. It is recommended that students intending to major in art plan to complete foundation studio courses (ART 101, 103, 207) and one art history course (ARH 251 or 252) in the freshman year. For graduation, a minimum of 36 credits in the major (maximum 51) must be completed, including: studio courses ART 101 (3), 103 (3), and 207 (3); art history courses ARH 251 (3), 252 (3); and two art history electives (6) at the 300 level or above, one of which must be selected from the following modern or contemporary art courses: ARH 331, 361, 362, 364, 374, 375, 376, 377, 380 (with topic approved by chair, 480 (with topic approved by chair).

Students must participate in ART 002, Sophomore Review, in the first semester of their sophomore year. Sophomore review is a special evaluation set up to provide individual studio art majors with timely feedback from the art department faculty once they have completed the foundation courses (ART 101, 103, 207) and are ready to take more advanced and specialized studios. Eligible students are Sophomore or Junior ART majors (BA or BFA) who have completed ART 101, 103, and 207 with at least a 2.3 GPA in those classes.

Eligible students should: Register for ART 002 in the first semester possible (freshman may register in the spring semseter for the Fall sophomore review). They should prepare a portfolio of 15 but no more than 20 of their best works from the Foundation courses. A student should fill out the Statement of Purpose form available in the Department office or website when registering for the course.

An additional six (6) credits must be selected from one of the following sequences of studio courses: ART 204, 304; 213, 314;

214, 315; 215, 316; 221, 322; 231, 332; 233, 334; 243, 344. This sequence must be completed by the end of the junior year. An additional three (3) credits of studio art on the 200 or 300level must be selected.

In the senior year, an additional six (6) credits must be selected from 300level studio courses (except 301) or ART 405. Many students choose to do an internship in their junior or senior year. Consult with your advisor before registering for ART 307 Art Internship.

A total of 120 credits is required for graduation. Students must

### NOTES

1. Students must participate in ART 002, Sophomore Review, in the first semester of their sophomore year (see below for more details). By the end of the sophomore year, the student is encouraged to complete at least 24 credits in studio art and at least 6 credits of art history.

2. Outstanding students may be permitted by the department to substitute other studio courses for the 100- and 200-level courses listed above after a portfolio review.

3. Many majors choose to do an internship in their junior or senior year. ART 300 Art Gallery Internship or ART 307 Art Internship. Consult with your advisor about how to set up an internship at an art gallery, design company, photography studio, or other appropriate business or organization.

### SOPHOMORE REVIEW: ART 002 (no credit)

Sophomore Review is a special evaluation set up to provide individual studio art majors with timely feedback from the art department faculty once they have completed the foundation courses (ART 101, 103, 207) and are ready to take more advanced and specialized studio subjects. Eligible students are Sophomore or Junior Art majors (BA or BFA) who have completed ART 101, 103, and 207 with at least a 2.3 GPA in those classes.
