**Academic Standard and Calendar Committee Report
#2015-16-3**

The Academic Standards and Calendar Committee met on February 12, 2016 and approved the following changes to Section 8.15.12 of the University Manual relating to the college level examination program (CLEP). These changes are needed to align course codes with the new general education outcomes designations.

Existing:

8.15.12 Students who earn credit for CLEP General Examinations shall be allowed to apply these credits toward the General Education requirements in the following manner:

Humanities Examinations: ART 1XA = 3 credits; ENG 1XA = 3 credits

Natural Sciences Examination: XXX 1XN = 6 credits

Social Science and History Examinations: SOC 1XS = 3 credits; HIS 1XL = 3 credits

College Composition: WRT 1XECw = 3 credits; WRT 2XECw = 3 credits

College Composition Modular: XXX XXX = 3 credits free electives; to earn an additional 3 credits WRT 1XECw, students must contact the Department of Writing & Rhetoric for optional proficiency test prior to earning 12 credits at URI

Mathematics: MTH 1XMQ = 3 credits; MTH 1XX = 3 credits

Humanities Examinations: ART **1A4** = 3 credits; ENG **1A4** = 3 credits

Natural Sciences Examination: **GNED 1A1** = 6 credits

Social Science and History Examinations: **SOC 1A2** = 3 credits; **HIS 1A3** = 3 credits

College Composition: **WRT 1B1** = 3 credits; **WRT 2B1** = 3 credits

College Composition Modular: **XXX 1XX** = 3 credits free electives; to earn an additional 3 credits **WRT 1B1**, students must contact the Department of Writing & Rhetoric for optional proficiency test prior to earning 12 credits at URI

Mathematics: MTH **1B3** = 3 credits; MTH 1XX = 3 credits
