# May 5, 2016 Faculty Senate Curricular Affairs Committee Five Hundred and Thirty-Third Report

At the April 25, 2016 meeting of the Curricular Affairs Committee and by electronic communication, the following matters were considered and are now presented to the Faculty Senate.

### **CURRICULAR CHANGES**

#### A. COLLEGE OF ARTS AND SCIENCES:

#### Creation of Landscape Architecture Minor: (see Appendix H)

The Landscape Architecture Department has seen a growing number of students inquire about how to obtain a minor in the discipline. For years the department has offered a minor in Landscape Architecture to students at URI, but it was never listed as a university approved minor. The existing minor has satisfied all of the requirements listed in the course catalog for minor degrees. Students were approved for a minor if they passed 18 credits from a list of required and elective classes from the following course codes CPL, LAR, PLS and ART, all class approved under the LAR curriculum. In recent years the department has moved from CELS to Arts and Sciences and the focus within the profession has changed. As a result, we have revised our minor by removing some classes, deemed less relevant in today's world, and replaced them with other classes considered more relevant. Some of those classes are offered through departments whose course codes include: BIO, GEO, and NRS. We have updated our description and the minor form that is used for keeping track of progress and student performance. As part of this process, we have received permission from each of the non-

The program currently exists and attracts 5 - 10 students from across campus per year. The courses are all offered and this requires a minimal amount of work to advise and sign the forms. Majority of responsibility rests with the students.

The Landscape Architecture BLA program is already an accredited program within the university and the College of Arts and Sciences.

There are no new courses being developed for the minor. Only courses that are on the books and offered by the departments of LAR (CPL), BIO, GEO, and NRS are included in the minor.

The minor fulfills all of the requirements as indicated in the course catalog: 18 credits and no more than 6 credits below 200 level.

It is possible that student may take LAR 201 as a distance learning class, provided that the student is able to sign up before the class student limit is reached. There is also a traditional lecture format course offering in the fall with 90 seats available.

Students are exposed to concepts, principals, and examples of landscape architecture design. They are shown landscape installations in urban, suburban and rural settings. They learn about landscape materials and practices and are instructed about the cultural applications relating to plants and their environments. Students are encouraged to meet with the program adviser or course instructors to develop a plan that fulfills each student's program needs.

4. Demonstrate that student learning is assessed based on clear statements of learning outcomes and expectations.

Each course includes statements about objectives and learning outcomes as required by the department and accreditation standards.

- F. FACULTY AND STAFF: The faculty and support staff for the program should be sufficient in number and demonstrate the knowledge, skills, and other attributes necessary to the success of the program.
  - 1. Describe the faculty who will be assigned to the program. The existing faculty (5.5 FTE's) are responsible for delivering the minor. There are no additional faculty assigned for the minor.

The minor will attract students looking to build knowledge and provide a concentration that can enhance their careers and job searches. The minor is not intended to compete with majors, but to enrich their education and provide an additional credential.

The chairman of the Department will keep track of the numbers of students signing up for the minor in LAR as a way of measuring student interest. As the BLA program is already reviewed through an accreditation process, most recently in October 2015 and approved for reaccreditation in February 2016, the classes are already reviewed by external evaluators (Learning outcome review), and this process will continue.

# **Minor Field of Study**

The minor in Landscape Architecture is for students who wish to expand their knowledge of the discipline of landscape architecture and to learn how human interventions impact the landscape. The minor requires a total of 18 credits, 9 of which are required with the remainder coming from selected elective courses.

LAR 201, LAR 202 and LAR 353 are the required core courses for the minor. In addition to these courses, completion of 9 credits of elective courses is required in consultation with the landscape architecture minor advisor. Courses include: BIO 262; CPL 450; GEO 120; LAR 302; LAR491/492; and NRS 100 and 300. These elective courses cannot be simultaneously counted toward a major. Major classes may be used as part of the minor if the student is not pursuing that particular major.
