The Academic Standards and Calendar Committee met on 2015-Dec-04, 2016-Feb-12, and 2016-Apr-08, and approved the following changes to Section 8.19.15 of the University Manual relating to nonmatriculating students. These changes were developed in collaboration with members of the Enrollment Services Advisory Committee (ESAC).

#### **Existing**

**8.19.15** At the end of each semester the dean or vice provost will review the academic records of all nonmatriculating students for whom he or she is responsible. Nonmatriculating students must earn a 2.00 QPA in each semester. Further registration for students who do not achieve this level may be denied by the Director of Enrollment Services on the recommendation of the dean or vice provost. The dean or vice provost will invite nonmatriculating students who are making satisfactory progress to become matriculating by admission or readmission as appropriate.

#### **Proposed**

**8.19.15** At the end of each semester the dean or vice provost will review the academic records of all nonmatriculating students for whom he or she is responsible. Nonmatriculating students must earn a 2.00 QPA in each semester. Further registration for students who do not achieve this level may be denied by the Director of Enrollment Services on the recommendation of the dean or vice provost. Nonmatriculating students who earn below a cumulative 2.00 QPA or have attempted in excess of 30 cr will receive a registration hold and will be required to meet with an academic advisor before further registration. The dean or vice provost will invite nonmatriculating students who are making satisfactory progress to become matriculating by admission or readmission as appropriate.
