

Some noteworthy items:

- Most do not hold classes on Columbus Day
- All hold classes on Election Day (New Hampshire does not have exams)
- Four universities give the entire week of Thanksgiving off (2 hold classes on the Wed. before Thanksgiving and 1 gives Wed. off)
- All have final exam periods less than 7 days

Item 3: Is it possible to condense the final examination period?

At the suggestion of Senators Hillary Leonard and Catherine Sama at the 2/23/17 Faculty Senate meeting, the Committee explored the option of reducing the duration of the final exam period. Section 8.70.23 of the University Manual currently requires a minimum of seven days be scheduled for final examinations. Saturdays and Sundays may also be used as final examination days under extraordinary circumstances.

The Committee discussed the matter with Enrollment Services and the option of eliminating the last day of final exams (December 22nd) which consistently contains two 3-hour timeslots for common exams (8-11 am and 11:30 am-2:30 pm) was discussed. It was noted that other common exam timeslots were available elsewhere in the final exam schedule.

In an effort to assess whether any faculty would be adversely affected by this change, the Committee requested that Enrollment Services provide a list of faculty members who used these timeslots in the past two semesters (SP16 and FL16). Only one faculty member was identified (Godi Fischer, ELE 480). The Committee Chair contacted Prof. Fischer and he had no objections.

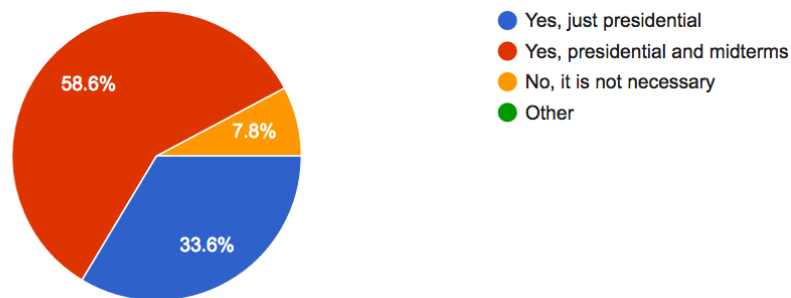
Condensing the final exam period to 6 days is possible but will require a change to the Manual.

Item 4: Does holding classes on Election Day prevent students from voting?

The Committee recently became aware of a survey conducted by Student Senate related to Election Day. The Committee Chair reached out to Student Senate (Cody Anderson, President of Student Senate, Victoria Russo and Ro Percy, student speakers at the February Faculty Senate meeting) and obtained the following results from Ms. Vanessa Garcia Polanco (Chair of the Student Senate Committee on Academic Affairs).

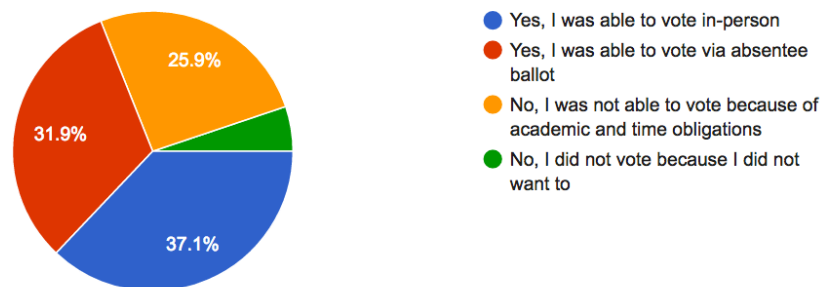
The online survey (available for over 6 weeks) was distributed via social media and included 116 undergraduate student respondents.

Would you support having election day off? (116 responses)



Given your academic schedule, were you able to vote this election?

Comments:

- When asked if they wanted Election Day off, 92% of students answered yes.
- When asked if they voted in the election, 73% of those that wanted to vote did vote (5% indicated they did not want to vote). Nationally, the voter turnout was about 60% for this past election¹.

Holding classes on Election Day does not prevent students from voting.

Item 5: Does the current voting policy in RI adversely affect undergraduate students?

According to the Rhode Island Board of Elections², “Rhode Island has joined 30 other states and the District of Columbia that now allow no excuse mail ballot voting. If you may not be able to get to the polls on Election Day, you can fill out a mail ballot application and receive a mail ballot.” A mail ballot application is available online. Thus, if a RI student is not able to get to the polls on Election Day, for any reason at all, they are still able to vote.

For out of state students from MA, CT or NJ, all states offer the opportunity to vote using an absentee ballot^{3,4,5}. Massachusetts also allows early voting⁶.

The current voting policies of RI and neighboring states do not adversely impact college students.

Item 6: What is the preference of the students and faculty if an extra day in the fall semester were available?

The Committee recently conducted a survey of all undergraduate students and faculty related to the fall semester. The survey was sent to all 543 tenure-track faculty members on 3/6/17 through the Faculty Senate and to all undergraduate students on 3/7/17 through URI Communications.

The two surveys were identical and contained only one question: “What would you do with an extra day in the fall semester? Rank the following options (1 = most preferred choice and 7 = least preferred choice). Select only one response per column.”

Seven choices were presented:

1. Start the semester a day later
2. Take Columbus Day off
3. Take Election Day off
4. Take the Wed. before Thanksgiving off
5. Have an extra reading day
6. Eliminate final exams on Sat.
7. End the semester a day earlier

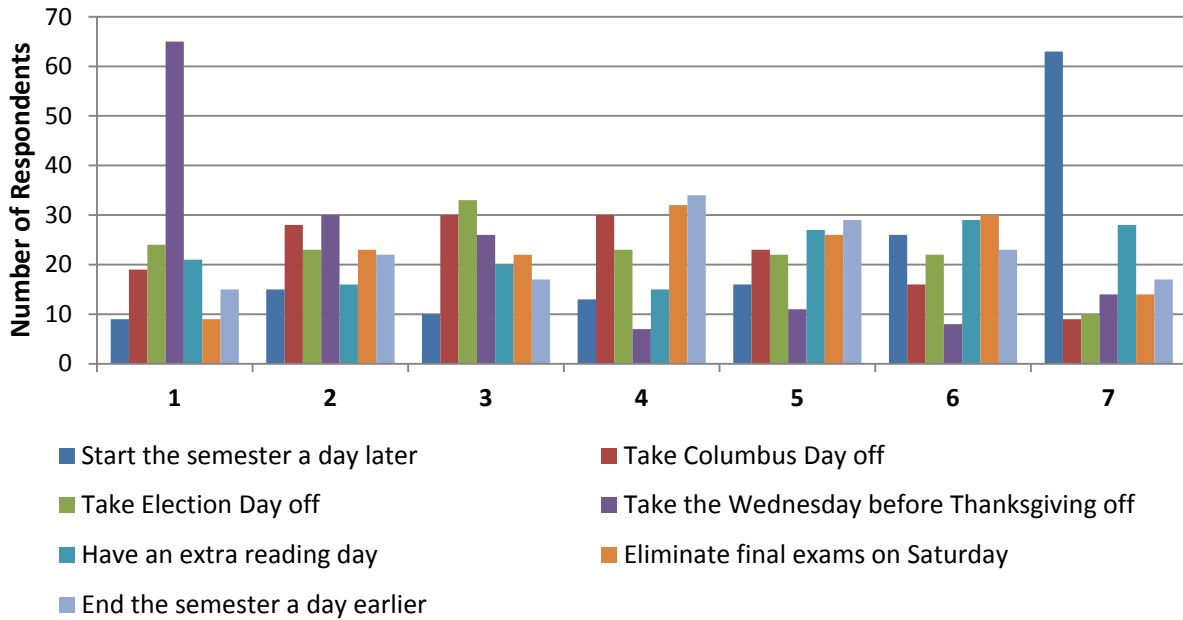

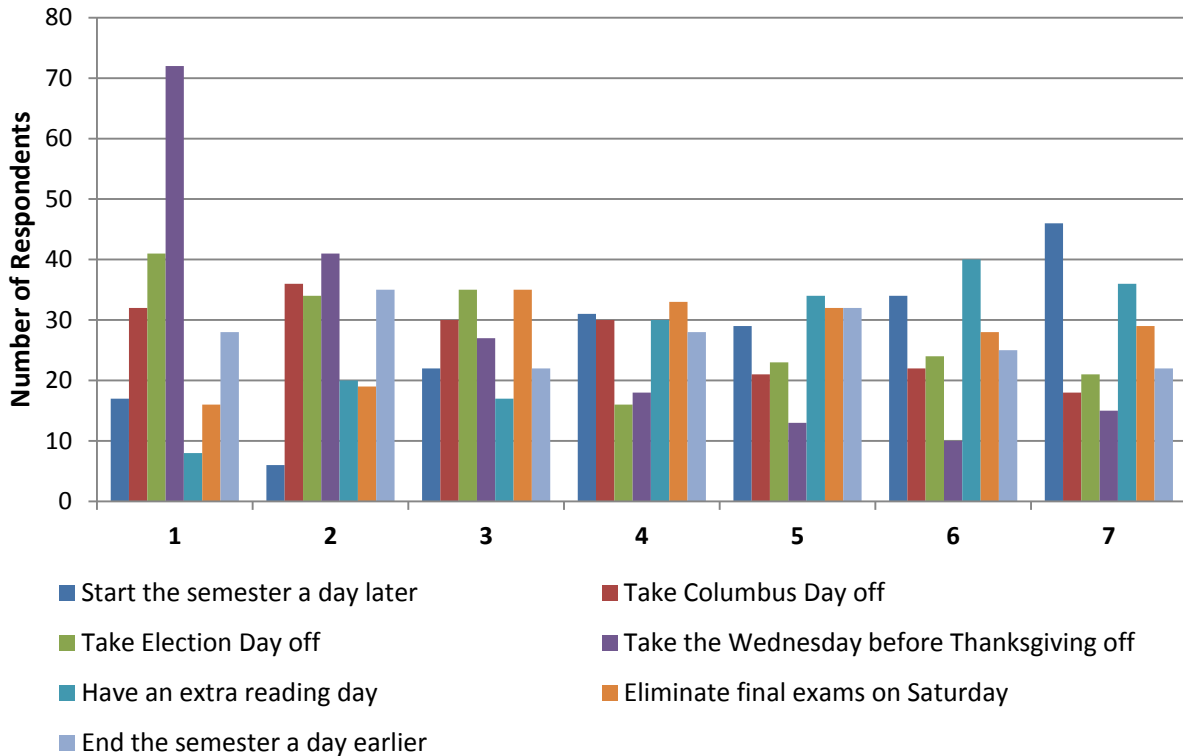

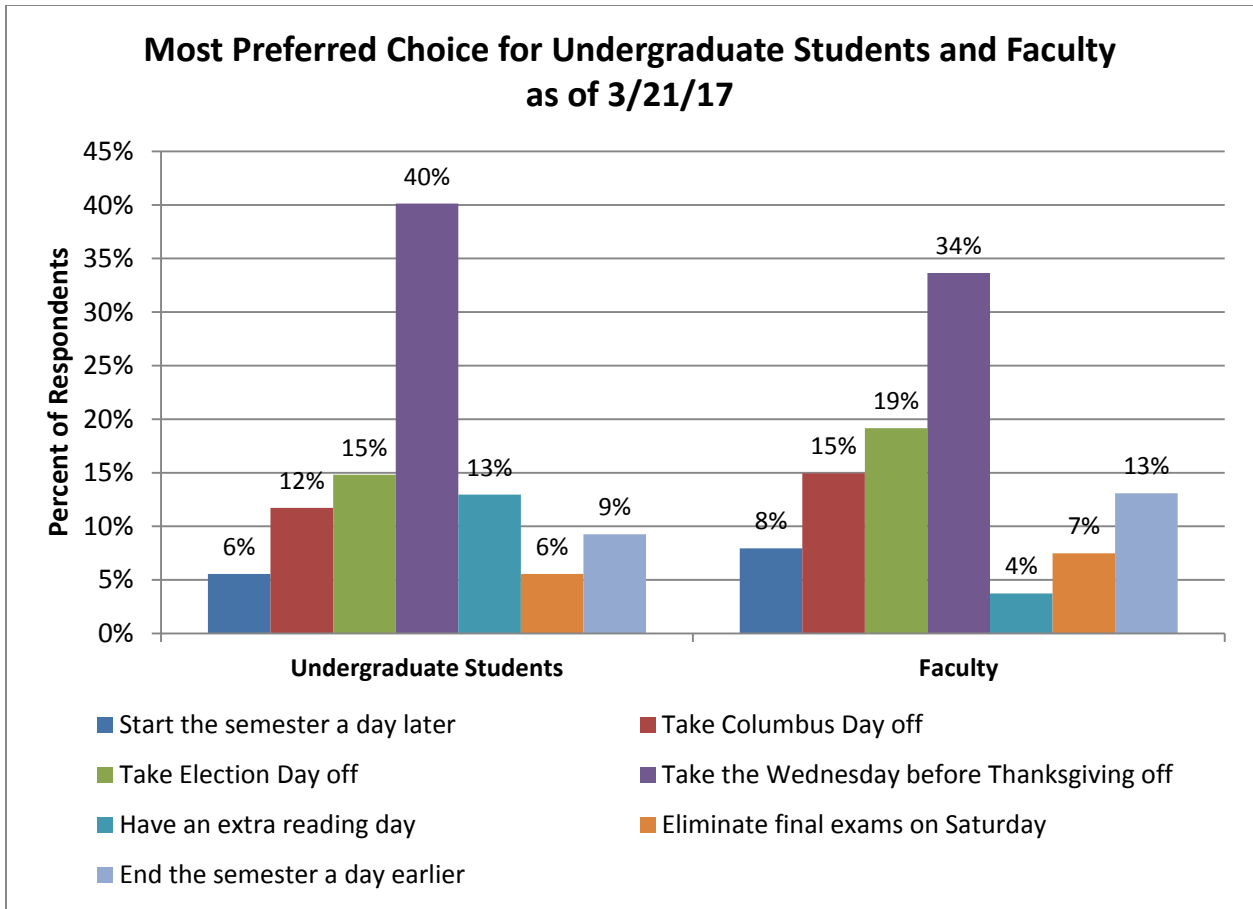

The top three priorities for both students and faculty were nearly the same:

1. Take the Wed. before Thanksgiving off (40% of students and 34% of faculty)
2. Take Election Day off (15% of students and 19% of faculty)
3. Take Columbus Day off (12% of students and 15% of faculty). *Note: 13% of students ranked having an extra reading day as their most preferred choice.*

A complete summary of the survey (with respondent comments) is provided as appendices.

The top request by both students and faculty is to take the Wednesday before Thanksgiving off.

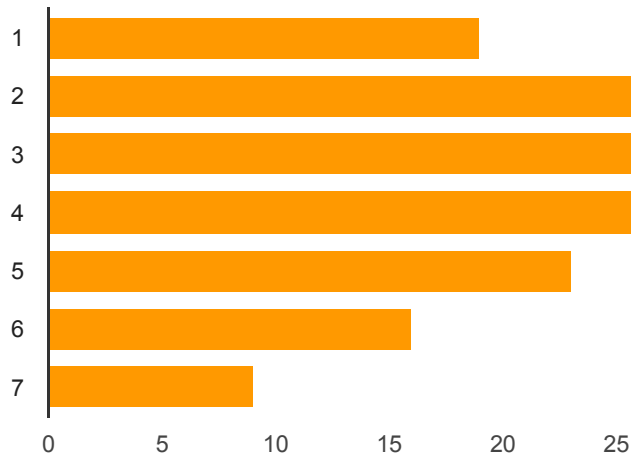

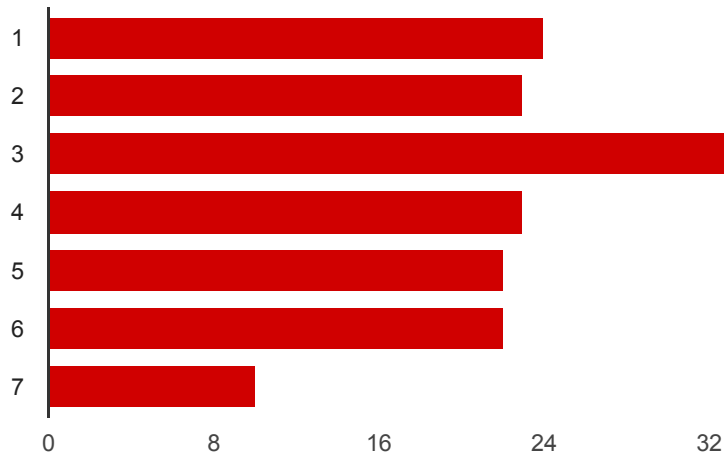

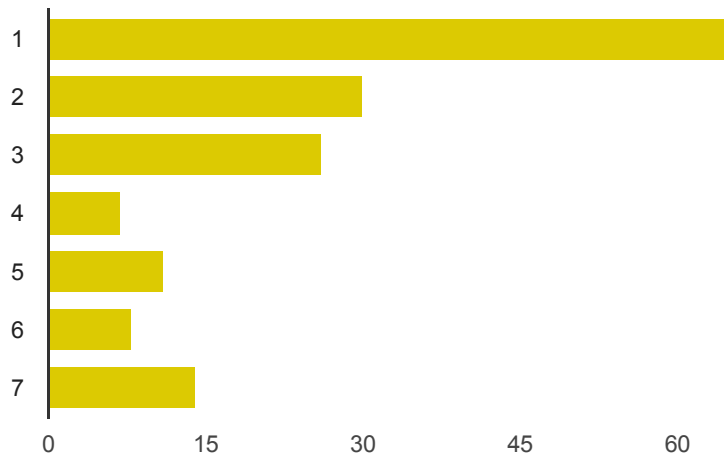

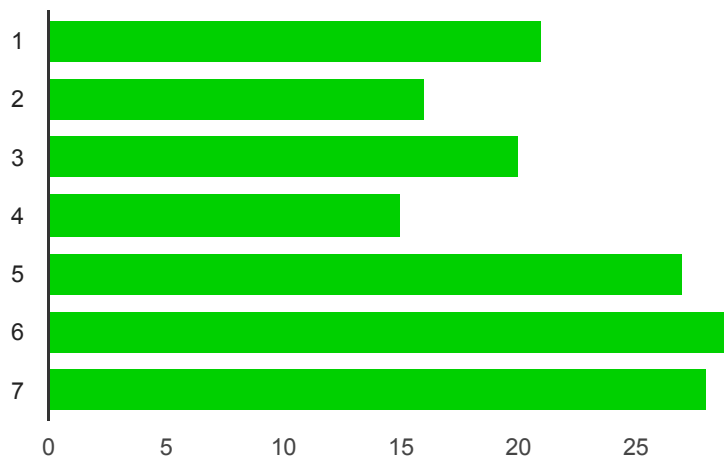

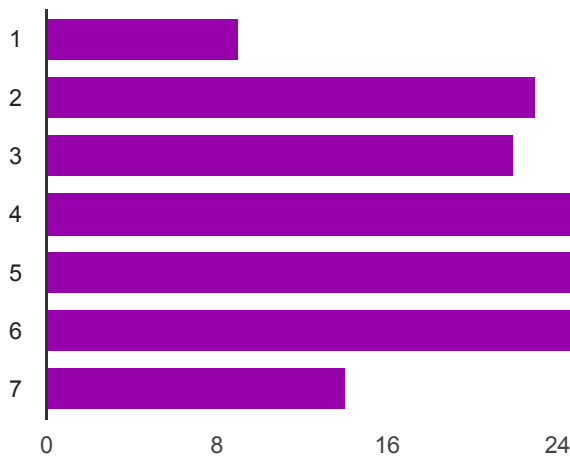

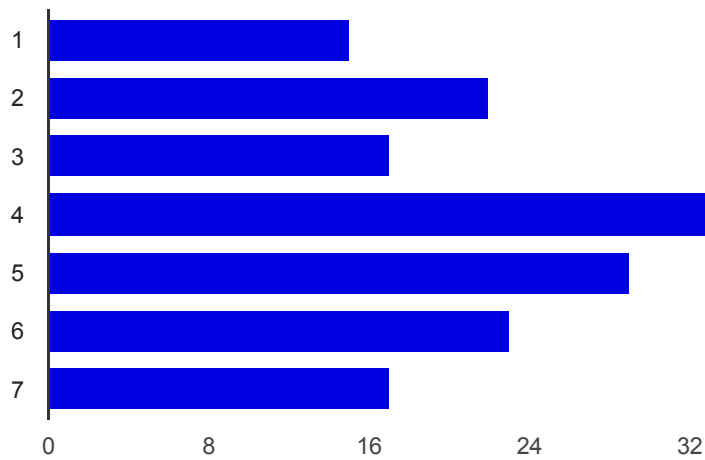

I want wednesday before Thanksgiving off.

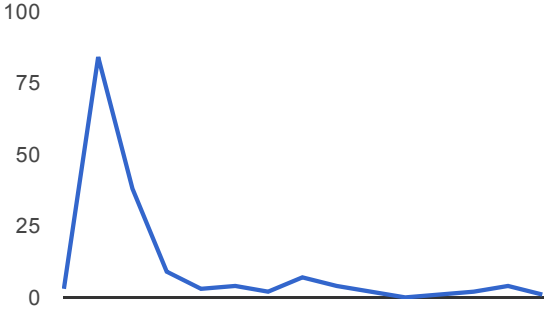

Number of daily responses



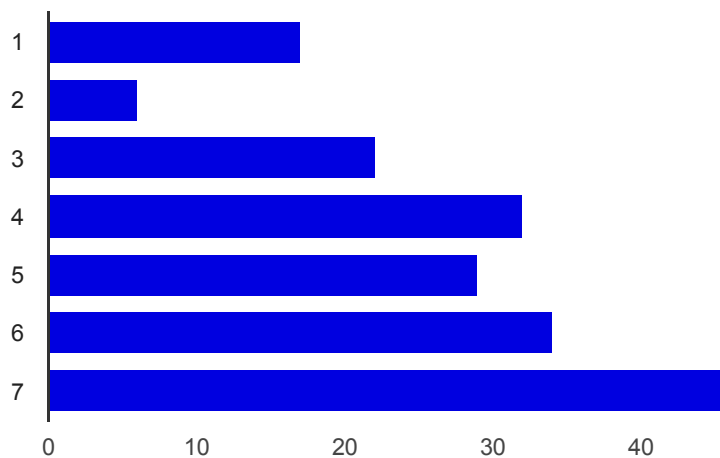

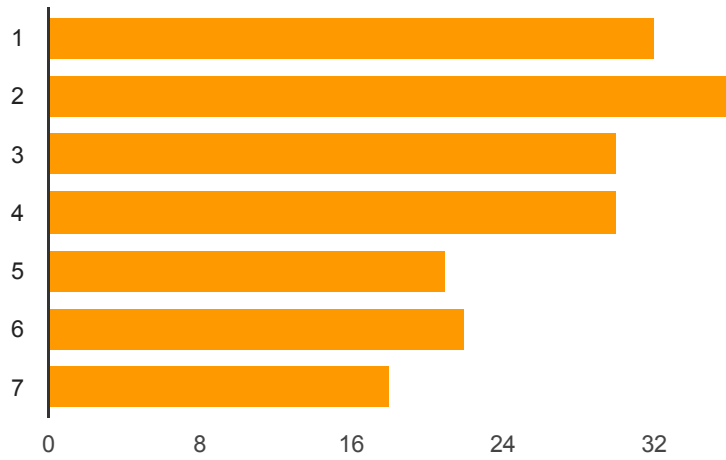

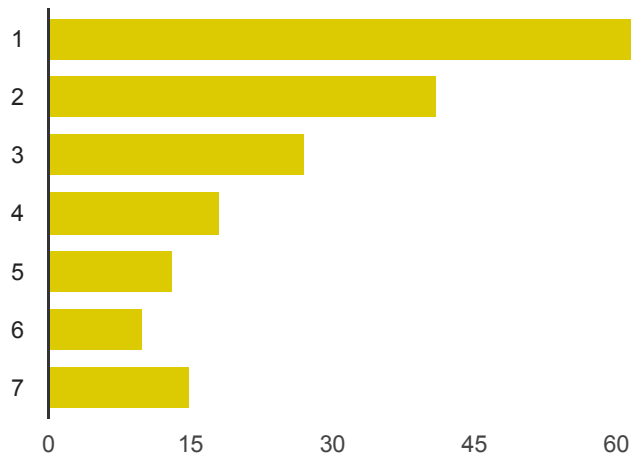

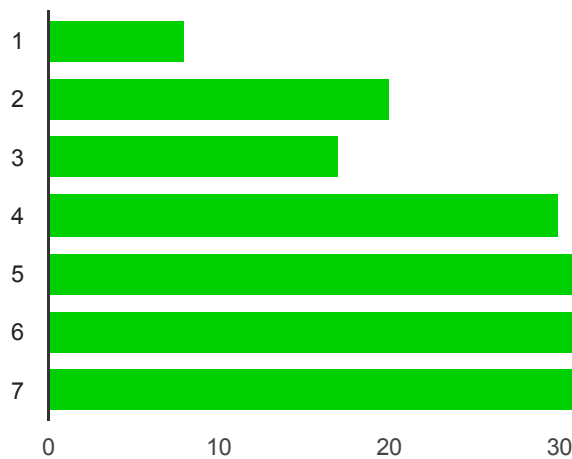

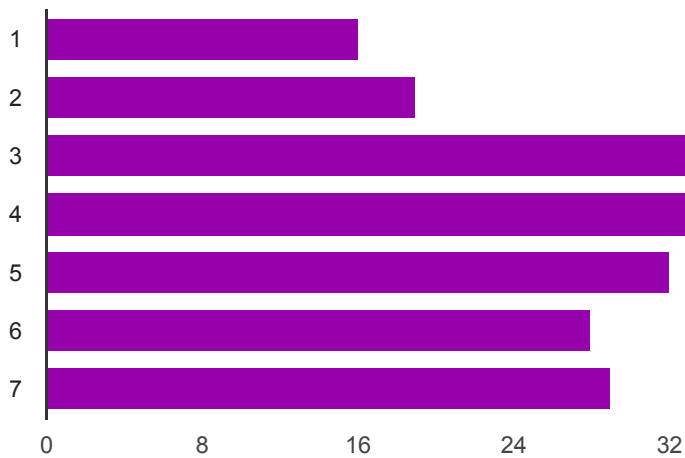

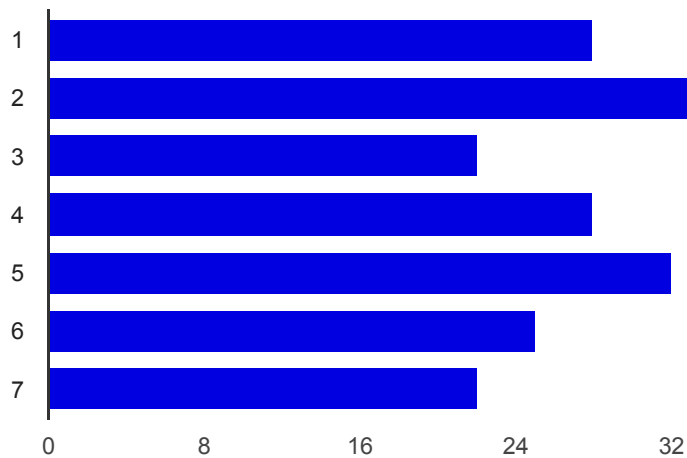

Comments:

Having Wednesday of Thanksgiving off would just mean more students skip that whole week. The best option would be to arrange the calendar so that would be a full week off, even if we started earlier and/or went longer.

I think most of us give the Wednesday before Thanksgiving off but if we do that then the students will leave on Tuesday.

I do not support Columbus Day as a holiday. If anything, it should become Indigenous Peoples' Day.

I do not support the Columbus Day holiday (unless the name is changed to "Indigenous Peoples" day or some such). I teach/ research the archaeology of the Americas.

Glorifying Columbus/ European colonization is problematic on so many levels.... Taking election day off seems unnecessary, given that the poll hours are so long (and I don't see most faculty/ students having troubles getting to polls). I am torn about the Wed before Thanksgiving. I like the idea, given that attendance is already so low. But, that no doubt leads to the slippery slope of students missing the entire week. No easy solution!

This ranking system privileges holidays at mid-semester that might provide students with time that might be used to manage the demands of increasing course loads (in the idealist's sense.) The mid-rankings 4-5 involve days that could be useful for faculty planning/adjustment perspectives.

I don't see how the first and final options bear on adding a day (they seem to cost us a day). A different question: would non-faculty staff get these days off too? If so, while I think for the students it would be best to get rid of the Wednesday before Thanksgiving

(many travel on that day), it seems the most civically responsible--and so overwhelmingly the best choice-- to have Election day off so that everyone can vote without missing a day of work.

no other comments

We have tried taking the Wednesday before Thanksgiving off- students took the entire week off and did not show up on Monday and Tuesday.

Wednesday before Thanksgiving has already become a sparsely populated day for those instructors who still try to teach on that day. We should all have Election Day off, but I listed it last since it only takes place once every four years.

It's nice to have the same days off as our school-aged children, when possible.

This is a biased survey because it attempts to detract from the real issue which is whether the university should provide all students with the opportunity to participate in the presidential election. Why not have a survey that directly asks that question?

Is this meant to be in non-presidential election years as well? Eliminating finals on Saturdays is my highest priority as this would help students who rely on weekend work to make ends meet. Saturday is also the sabbath for Jews and some Christian denominations.

In my 25 years at URI, there has only been one year with the Weds before Thanksgiving with no classes. Classes on that Monday and Tuesday were very poorly attended.

EITHER have classes M-W, or have the whole week off

Have the first day of Rosh Hashana as a day off/or Yom Kippur

How about an extra day for classes?

I don't think we should be shortening the semester, and especially eliminating classes on the Monday schedule where it seems like most holidays are.

No point in having days off that are not state holidays also

I'd end the semester a day earlier on Friday. This effectively gives four reading days before the first exam. Thus in essence there would be three/four exam days (ThFS/S), two reading days (SS/M) and then the four/three exam remaining exams days (MTWTh/F) depending upon the year (with the last day used for the make up day). My concern with taking Wednesday off before Thanksgiving is students would take the full week off under the rationale they would only be missing 2 days of class; this rationale also applies to Columbus Day and Election Day which start to be used as 4-day weekends.

I tried to get the Wednesday before Thanksgiving off a few years ago when on the AS&CC. I teach at 9 AM on Wednesday and usually see only 50% attendance that day. I currently view that day as wasted.

The rationale for Election Day being off, is that students will interpret that as a sign from the university that voting is important, but we cannot assume that is the case.

Unfortunately many students just see it as a 4-day weekend (I teach Monday classes so

I can attest to that), or another reason to party. If it is decided to have Election Day off, then it is critical that URI emphasizes the importance of voting to assure that students see our rationale for the day off. For the majority of our students, this is their first time voting, and that value might not yet be instilled. If it is decided to not have Election Day off, then it is critical that URI educates our students about the importance and procedures of absentee voting. This is how I voted from the time I became 18 until I started my faculty position at URI, including 3 different states, and during my post-doc in The Netherlands. My vote counted just as much as votes from people who lived next door to the polling places. In life beyond URI, many of our students will not have the day off, and will have to find a way to vote. It is up to us to educate our students about the importance of carrying out their right to vote, and to find a way to do it no matter what circumstances might surround Election Day for them. The academic year under discussion (2022) is not a presidential campaign, yet the academic calendar for 2020 is a presidential campaign, and Election Day is not slated as being off. Perhaps that is a point of discussion too.

While I might personally like a different day off, I think it is important that the University encourage everyone - ESPECIALLY students to become active engaged citizens. The state offices are closed by law. I feel it is hypocritical to the students - and partially "illegal" to have faculty work - on election day.

I know why you're asking, and I know I'm supposed to say take election day off as #1, but I don't really feel that way. Honestly, I don't see a need to change the calendar at all. Election day is NOT a holiday in this country. My department teaches mostly online so this matters not a whit for our students. Perhaps other faculty could adapt their election day lesson plans to online for that week if they wish to give their students the time to go to the polls.
