

Per the Graduate School: "In January 2017, the Graduate Council approved a change in policy regarding comprehensive exams. Comprehensive exams for non-thesis Master's students are now optional. A culminating experience (determined by the Graduate Program) is required for all non-thesis master's programs."

Students enrolled in the non-thesis MLIS program in GSLIS will still be required to complete a "culminating experience" by enrolling in LSC 595: Apply and Reflect or LSC 596: School Library Media Practicum, both of which require an electronic portfolio involving significant work and demonstration of students' achievement of GSLIS learning outcomes.

EXISTING CATALOG LANGUAGE:

*Program requirements:* 36 credits, 18 in required core courses (LSC 502, 504, 505, 508, 557, and 595), except for the School Library Media Track which requires 21 credits of core courses: (LSC 502, 504, 508, 557, and 9 credits of 596). All students are required to take a written comprehensive examination. Up to 6 credits of interdisciplinary study may be taken in courses outside library science when relevant to the student' specialization; no more than six credits or two courses may be taken in non-matriculating status for transfer into the degree program.
