Faculty Senate Curricular Affairs Committee Five Hundred and Forty-sixth Report

At the January 29, 2018 meeting of the Curricular Affairs Committee and by electronic communication, the following matters were considered and are now presented to the Faculty Senate.

SECTION II Curricular Matters Which Require Confirmation by the Faculty Senate

University Manual Chapter 8 – Regulations for Students Courses, Course Enrollment and Fees

Proposed:

8.32.10 Course Credits. The normal maximum rate at which academic credit may be earned at the University of Rhode Island is three credits per two-week session or four credits per three-week session. This limit applies to individual courses and to combinations of courses that may be offered in a single session. Sponsors of any course or session which would exceed this limit must provide special justification for their proposal. For existing eCourses that do not adhere strictly to standard, published academic calendars to be taught during unusual time frames during the academic year and for all new courses, this course justification shall be approved by provided to the Curriculum and Standards Committee and/or the Graduate Council. For existing courses to be taught during the summer, justification shall be provided to the Dean of the Alan Shawn Feinstein College of Continuing Education.

Changes Incorporated:

8.32.10 Course Credits. The normal maximum rate at which academic credit may be earned at the University of Rhode Island is three credits per two-week session or four credits per three-week session. This limit applies to individual courses and to combinations of courses that may be offered in a single session. Courses that do not adhere strictly to standard, published academic calendars shall be approved by the Curriculum and Standards Committee and/or the Graduate Council.
